1 RULES

- 1.1** The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.

2 ELIGIBILITY AND ENTRY

- 2.1** The regatta is open to all boats of the PHRF class. Individual starts will be given to the following classes:

Class 1 Spinnaker

Class 2 Performance Jib & Main

Class 3 Non-Spinnaker Cruising (High tech sails NOT permitted)

Class 4 PHRF 240+

- 2.2** An entry form is part of this NOR.

3 FEES

- 3.1** The REGISTRATION fee for all boats is \$50.00. REGISTRATION is by completing the attached form and submitting it together with the required fee, postmarked by July 28, 2008.

- 3.2** The LATE REGISTRATION fee for all boats is \$65.00. LATE REGISTRATION is for registration documents postmarked after July 28. In addition LATE REGISTRATION will be accepted on the deck of the Oriental Marina and Inn (OM&I) 1700 to 2000 Friday August 1st, and 0730 to 0830 August 2nd.

- 3.3** You may avoid LATE REGISTRATION by calling or e-mailing your intent to race including all information required, by July 28, and presenting completed documents to the LATE REGISTRATION desk prior to 0830 on Saturday. - 3.4** US Sailing members are eligible for a \$5.00 discount.

- 3.5** Saturday dinner tickets are available with registration for \$15.00 each. See ENTRY FORM.

4 SCHEDULE

- 4.1** Dates of Racing: August 2 and 3, 2008.

- 4.2** A Skipper's Meeting will be held at 0900 on Saturday August 2 on the deck at the OM&I.

- 4.3** Number of races: There will be two races scheduled on Saturday and one race on Sunday.

- 4.4** The time of the warning signal for the first race on Saturday is 1100. The warning signal on Sunday will be at 1000.

- 4.5** There will be a cash bar social at the Tiki Bar at the OM&I following racing with a dinner on the grounds of the OM&I at 1800.

- 4.6** Awards will be at the end of racing on Sunday at approximately 1430.

5 RATING CERTIFICATE

Each boat shall submit a copy of a valid NC-PHRF rating certificate with the registration documents. Boats without a valid NC-PHRF rating certificate will be assigned one by the ODC measurer.

6 SAILING INSTRUCTIONS

The sailing instructions will be posted on the ODC website. Copies of the sailing instructions will be available at the LATE REGISTRATION desk after 1700 on Friday August 1st and will be posted on the Official Bulletin Board.

7 VENUE

7.1 Regatta headquarters will be on the deck of the Oriental Marina and Inn on the harbor in Oriental NC. The races will be held in the waters off of Oriental NC.

8 THE COURSES

The courses to be sailed will be triangular or windward/leeward and will be posted on the signal boat. "W" is windward/leeward and "T" is triangle. The number of LEGS will be indicated after the W or T. "T3" is a 3 leg triangle. Diagrams will be included in the sailing instructions. Inflatable tetrahedrons will be used as marks and will all be left to port.

9 SCORING

9.1 The classes may be divided into divisions, for scoring purposes only, depending on the number of entries. All races sailed will be included in a boat's series position

10 SUPPORT BOATS

Support boats shall be identified at the Skippers Meeting.

11 DOCK SPACE

Dock space may be available at the OM&I (252-249-1818). Dock space is available at no cost to participating boats at Whittaker Pointe Marina. Call Henry Frazer (252-249-2210). Transportation to town is necessary from this marina. ODC can arrange.

12 PRIZES

Up to three trophies will be awarded to each class or division depending on the number of entries. The season ICRC trophy will be awarded to the club with the best season score.

13 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

14 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance.
